# COVID-19 and hearing loss—A narrative review

Interest in hearing loss associated with COVID-19 has increased since the pandemic started. Early on during the spread of SARS-CoV-2 across the globe, reports of smell and taste disorders secondary to COVID-19 emerged, and to a lesser extent, reports of sensorineural hearing loss also surfaced. This raised questions regarding changes in the epidemiology of hearing loss and modifications to otologic practice that have evolved in response to the COVID-19 pandemic. To elucidate these questions, we performed a comprehensive literature search, including articles up to November 2022, using "COVID hearing loss" in MEDLINE. A total of 153 articles were included for full-text review and data extraction. There are several proposed mechanisms through which COVID-19 may contribute to hearing loss-direct viral infection, microthrombi, or hemorrhage. There is a growing repository of case reports and series on SARS-CoV-2-associated sensorineural hearing loss, with variable quality. Most patients who experienced hearing loss did so within a month of infection, with most patients' symptoms resolving within 2 weeks. The growing body of literature discussing SARS-CoV-2-associated hearing loss does not suggest a significant rise in the occurrence of sensorineural or overall hearing loss. In this ongoing COVID-19 era, hearing loss should be approached in the same state-of-the-art manner as before the pandemic.

# 1. Introduction

COVID-19 is an emerging viral disease caused by the *severe acute respiratory syndrome coronavirus 2* (SARS-CoV-2) (Figure 1), which first emerged in Wuhan, China, in December 2019. It has since spread to the rest of the world, reaching pandemic status in March 2020. According to the World Health Organization, as of May 28<sup>th</sup>, 2023, over 767 million confirmed cases and over 6.9 million deaths have been reported globally (WHO, 2023). From the beginning, COVID-19 has changed the practice of medicine. Although the absolute number of otolaryngological emergencies drastically decreased during the pandemic (Gelardi et al., 2020; Pontillo et al., 2020; Chari et al., 2021; Riemann et al., 2021; Pereira et al., 2023), the virus and its sequelae have brought otolaryngologic expertise to the forefront of medical care (Pandian and Brodsky, 2021). Perhaps the most far-reaching effects on the public were bringing to light the actual depth of the nasal cavity when undergoing a nasopharyngeal swab test.

In addition, over time, the world began to recognize smell and taste disorders—an underrepresented aspect of rhinology and expanded the relevance of these disorders to the general population and not just patients with olfaction-reliant professions. Finally, patients with severe acute respiratory failure requiring prolonged mechanical ventilation often relied on longitudinal and interdisciplinary care facilitated by otolaryngologists for both tracheostomy placement and subsequent encounters; this was especially true in cases involving long-term sequelae such as airway stenosis, dysphagia, and dysphonia. Among other symptoms and signs, hearing loss attributed to COVID-19 has been the subject of increasing medical attention within the literature.

This narrative review will focus on COVID-19 and its effect on hearing, as, even 3 years after the beginning of the pandemic, specialists and general clinicians still struggle to answer when a patient or a colleague asks if SARS-CoV-2 may be responsible for hearing loss. Using our clinical experience and a comprehensive literature review, we aim to address the following questions: Has COVID-19 changed the epidemiology of hearing loss, and has the otologic practice changed in response to the pandemic?

# 2. Materials and methods

The terms "COVID hearing loss" were searched in MEDLINE using PubMed in June 2022. Two hundred ninety-eight abstracts were screened; criteria for inclusion were English language manuscripts that discussed possible hearing loss after SARS-CoV-2 infection, vaccination, or treatment for the disease. Manuscripts that discussed broader, non-hearing loss related issues during the pandemic were excluded. 10 additional manuscripts, encompassing articles published up until November 2022, were identified after the initial screening processes and included in this review. Overall, 153 articles underwent full text review and data extraction (Figure 2).

# 3. Results

## 3.1. Viruses and hearing loss


Hearing loss is considered the fifth leading cause of disability in the world, and its prevalence constantly increases with the aging population (WHO, 2019). Hearing loss is associated with lower professional achievements (Chadha et al., 2017), impairment of social interactions, and cognitive decline (Cherko et al., 2016). Hearing loss is divided into three categories: (1) conductive hearing loss, where there is mechanical impairment of the external soundwave transmission to the inner ear, (2) sensorineural hearing loss (SNHL), where there is a neurological inability to transduce a soundwave into an electrical signal that is then interpreted by the brain, and (3) mixed hearing loss, where conductive and SNHL are combined. Conductive hearing loss has many etiologies, among which the most common is the transient middle ear effusion during an upper respiratory tract infection. Conductive hearing loss is frequently reversible as the etiology is mechanical in nature, and either self-resolves or may be surgically correctable. On the other hand, SNHL is usually permanent, as the mechanosensory inner ear hair cells do not regenerate. In particular, sudden sensorineural hearing loss (SSNHL) is a well-recognized type of SNHL, with many possible etiologies (infectious, neoplastic, immunological, circulatory, and neurologic), although primarily idiopathic (Hughes et al., 1996). To date, treatment of SNHL is limited to conventional hearing aids and cochlear implants, which only partially alleviate the symptoms.

The inner ear is vulnerable to certain viruses which may induce SNHL, such as herpes simplex (HSV), varicella-zoster virus, cytomegalovirus (CMV), Epstein-Barr virus, mumps, measles, rubella, hepatitis, human immunodeficiency virus (HIV), Lassa, Zika, Ebola, enterovirus, West Nile virus, or lymphocytic choriomeningitis virus (LCMV) (Cohen et al., 2014; Ficenec et al., 2019; Jeong et al., 2021). The mechanisms may include viralmediated auditory neuritis, cochleitis, cross-reaction of antigens in the inner ear (Kilic et al., 2020), microvascular involvement, and, less likely, temporal lobe involvement. Coronaviruses can also cause otitis media (Liaw et al., 2021; Marom et al., 2021); however, no literature links hearing loss or vestibular symptoms with the two previously encountered types of severe acute respiratory syndrome coronaviruses [severe acute respiratory syndrome (SARS) and middle east respiratory syndrome (MERS)] (Almufarrij et al., 2020).


# 3.2. Pathophysiology of COVID-19 infection

SARS-CoV-2 infects cells through the angiotensin-converting enzyme 2 (ACE2) receptor and can infect central and peripheral nervous systems (Wan et al., 2021). Given the virus' affinity for mucosal surfaces, the ear is vulnerable to the virus through the mucosal path from the nasopharynx provided by the Eustachian tube. Of note, goblet cells lining the Eustachian tube and middle ear mucosa express ACE2 receptors; the presence of these receptors supports the theory that the Eustachian tube may play an important role as an entry route for SARS-CoV-2 into the middle ear (Jeong et al., 2021). The cochlea itself, while housed mainly in bone, still possesses semi-permeable openings, namely the round window membrane and stapedial annular ligament and footplate (Salt and Plontke, 2009). Thus, the inner ear may be infected by the virus not only through nervous system infection but also through continuity with infection-vulnerable mucosal surfaces in the middle ear. In several studies conducted on intra-operative ears and on cadaveric specimens, SARS-CoV-2 has been detected in the mastoid and middle ear (Frazier, 2020; Jeican et al., 2021; Raad et al., 2021; Kurabi et al., 2022).

SARS-CoV-2 may also be implicated in hearing loss through other indirect mechanisms. For example, with its propensity for increasing the incidence of microthrombi and microhemorrhage (Wan et al., 2021), SARS-CoV-2 could theoretically induce SNHL, given that the inner ear is a sensitive organ with terminal vascularity and, therefore, vulnerable to ischemia (Figure 3) (Tabuchi et al., 2002; Mom et al., 2005; Gyo, 2013). Additionally, ischemic stroke and hemorrhagic transformation—both seen in severe COVID-19—along some portions of the auditory pathway could theoretically induce SNHL, although rare (Bamiou, 2015). In the following sections, we review published studies that contribute to

our understanding of COVID-19's place in the landscape of viral hearing loss.

# 3.3. Direct effects of COVID-19 on hearing


# 3.3.1. Otitis media

SARS-CoV-2 can induce acute otitis media (Raad et al., 2021), and a multicentered prospective study comparing audiometry and

symptoms in 331 patients with and 80 without COVID-19 did not find a difference in the hearing status of the infected patients, even at 3 months follow-up, although they may present with aural symptoms (Bhatta et al., 2022).

# 3.3.2. Sudden sensorineural hearing loss

Most of the articles about COVID-19 and SSNHL are case reports, which by their nature have limited generalizability and

can only be used to establish associative, not causal, relationships. No definitive conclusions could be drawn from systematic reviews and meta-analyses conducted at various time points (Almufarrij and Munro, 2021; Fancello et al., 2022; Jafari et al., 2022; Maleki et al., 2022). One systematic review and meta-analysis suggested that SARS-CoV-2 may impair hearing, but most available literature relies on case reports (Fancello et al., 2022). It is well known in the research community that association does not equate with causality; as such, the temporal association between SNHL and an active SARS-CoV-2 infection does not necessarily imply a causal relationship. That said, rare potential COVID-19-induced SSNHL cases with more robust causality were also reported, describing—in addition to concomitant SARS-CoV-2 infection—unusual clinical and radiological features, suggesting unusual SSNHL etiology.

The main features noted by these case reports included bilateral involvement and magnetic resonance imaging (MRI) changes compatible with labyrinthitis or intra-labyrinthine hemorrhage (Figure 3) (Chern et al., 2021; Edwards et al., 2021; Ozer and Alkan, 2021; Perret et al., 2021; Da Silva et al., 2022). Importantly, when hearing loss was correlated with MRI abnormalities, the severity increased, bilateral in half of the cases, without recovery (Fancello et al., 2022).

In a survey of more than 200 American otorhinolaryngologists in March 2021, most did not notice any rise in SSNHL incidence during the pandemic (Pool et al., 2022). Most studies exploring the incidence of SSNHL during the pandemic compared to before the pandemic found no difference (Aslan and Cicek, 2021; Chari et al., 2021; Chao and Young, 2022; Parrino et al., 2022). Some found a decreased incidence of SSNHL (Doweck et al., 2022), some an increased incidence, without clear explanation (Wichova et al., 2021). In one study, no SARS-CoV-2 infection was found in 25 consecutive SSNHL patients during the pandemic (van Rijssen et al., 2022). A systematic review from 2022 found inconsistent and contradictory results, unable to determine whether SARS-CoV-2 has contributed to the increased incidence of SSNHL worldwide (Meng et al., 2022a).

Overall, studies agreed that hearing loss during the pandemic or active SARS-CoV-2 infection should not sway the clinician from following the standardized audiological workup (Guigou et al., 2021; Malesci et al., 2022). These patients should still be managed according to clinical practice guidelines, for instance, guidelines published by the American Academy of Otolaryngology-Head and Neck Surgery (Chandrasekhar, 2019).

## 3.3.3. Congenital hearing loss

SARS-CoV-2 has the potency to be vertically transmitted from the infected—even asymptomatic—mother (Sevilla-Montoya et al., 2021; Vigil-Vázquez et al., 2022), and therefore could affect the hearing of newborns in a similar manner as other hearingnociceptive congenital viruses (CMV, *rubella*, LCMV, HIV, HSV, *Zika*). Although the follow-up is relatively short, a recent systematic review found some publications demonstrating that maternal COVID-19 does not affect newborn hearing, whereas some found an effect, especially in mid- and late-stage pregnancy (Meng et al., 2022b). Putative pathophysiological mechanisms include systemic hypoxia in the mother, intrauterine hypoxia secondary to placental dysfunction, and vertical transmission through the placenta. The authors conclude that whether SARS-CoV-2 infection in mothers will affect the hearing of newborns remains unclear.

Adjacent to the potential direct vertical effect of SARS-CoV-2 on newborn hearing, the pandemic has affected congenital hearing loss through delayed diagnosis. Congenital hearing loss affects 1– 2 per 1000 births, impairing speech development, especially if late diagnosed (Lieu et al., 2020). Early detection and intervention are paramount for cognitive and social development. For this reason, within the last 25 years, several countries implemented systematic neonatal hearing screening in the maternity ward (Grandori, 1999), with effective results (Nelson et al., 2008; Edmond et al., 2022). Depending on the waning and waxing phases of the pandemic, the usual course of medical care was compromised, including access to universal neonatal hearing screening. Additionally, an increase in births out of the hospitals has been described. A study estimated that up to 50% of infants born with hearing loss in Maryland (USA) in 2021 may be delayed in diagnosis due to the pandemic (Jenks et al., 2022).

# 3.4. Indirect effects of COVID-19 on hearing

### 3.4.1. Ototoxicity

Apart from SARS-CoV-2 itself, many medications used to treat patients with COVID-19 are considered potentially ototoxic. These medications include quinine-derivatives (Altulea et al., 2021; Singh et al., 2021), which were ineffective in treating COVID-19 infection, loop diuretics, and antiviral drugs (Monteiro, 2020; Prayuenyong et al., 2020; Coffin et al., 2021; De Luca et al., 2021; Little and Cosetti, 2021). Admission to the intensive care unit (ICU) also confounds the incidence of SNHL in COVID-19 patients, given that these patients are more likely to be treated with ototoxic loop diuretics and may require dialysis for renal insufficiency or suffer from septic shock. Therefore, unusual SNHL during and after ICU could be incorrectly (Gerstacker et al., 2021) attributed to SARS-CoV-2. A systematic review found that, although uncommon, the likelihood of bilateral SSNHL was significantly higher in COVID-19 patients than in the general population, which may represent the bilateral nature of ototoxicity-driven SNHL (Meng et al., 2022a).

#### 3.4.2. Vaccination

Cases of SSNHL after COVID-19 vaccination have been reported, though the causality remains unclear. Several of immunization-induced pathophysiological mechanisms SNHL have been proposed, such as immunocomplex-mediated autoimmune response directed toward the cochlea (Okhovat et al., 2015), or reactivation of latent virus resulting in cochlear inflammation. As side effects of newly developed COVID-19 vaccines were subject to public and scientific scrutiny, proper studies specifically assessed the risk of SNHL, with comforting conclusions (Pisani et al., 2022). No association between vaccination and an increased rate of SSNHL compared to the expected incidence in the general population was noted in a large analysis (Formeister, 2022). Another study concluded that an increased risk of SSNHL might be associated with Pfizer vaccine, however with a minimal effect size (Yanir et al., 2022). The most frequent otolaryngological side-effects of COVID-19 vaccines are audio-vestibular symptoms, but none severe or life-threatening, and the underlying mechanisms are still mostly unknown (Colizza et al., 2022). Thus, COVID-19 vaccine-related SSNHL is considered rare, and the benefit of vaccination far outweighs the risks (Pisani et al., 2022; Ulrich et al., 2022).

## 3.4.3. Communication impairments with masks

The hearing-impaired population indirectly encountered negative consequences on their hearing during the pandemic for two main reasons. First, face masks hide lip movements and decrease speech recognition, especially in higher frequencies; this becomes more apparent in levels of high background noise (Magee et al., 2020; Rahne et al., 2021; Toscano and Toscano, 2021; Seol et al., 2023). Second, social distancing led to increased physical distance between people, which reduces the signal-to-noise ratio of sound. Consequently, there was more anxiety and stress during the pandemic in the hearing-impaired population than in the standard population (Maleki et al., 2022).

# 4. Discussion

In April 2020, the first article reporting a case of SNHL attributed to COVID-19 was published in Thailand, the second country touched by the pandemic after China (Sriwijitalai and Wiwanitkit, 2020). Unfortunately, no quantification nor qualification of the hearing loss was described, and apart from the presence of concomitant SARS-CoV-2 infection, no evidence of causality could be drawn. Case reports with similar observations appeared progressively during the pandemic, describing the occurrence of SNHL in patients infected with SARS-CoV-2. Since the world medical corps and the public had no experience with COVID-19, any symptoms during active infection could be attributed to the emergent disease. As such, the literature was flooded with case reports and series that appeared to be lower in quality, in attempt to quickly disseminate information on this novel virus. Given the uncertainty surrounding the disease, the pandemic opened the door to a suboptimal review process and allowed for less rigorous research methods during the publishing frenzy, leading to a substantial number of retracted articles (Bramstedt, 2020; Shimray, 2022).

Self-reported hearing loss and other ear symptoms-such as discomfort, fullness, and tinnitus-are nonspecific and frequently occur in many systemic and upper respiratory viral illnesses. Conductive hearing loss resulting from middle ear effusion is expected and will resolve spontaneously without impairing long-term cochlear function. Conversely, SNHL can potentially impair long-term hearing and should be addressed differently. Additionally, a mild sensorineural hearing loss associated with middle ear effusion is more compatible with an otitis media (Malesci et al., 2022) than with an unusual SNHL supposedly attributed to COVID-19 (Gunay et al., 2021), having in mind that the accuracy of the-inherently subjective-audiometry depends on the physical and psychological state of the patient. Hearing symptoms are frequent and likely due to transient middle ear involvement and Eustachian tube dysfunction, without abnormal hearing threshold shift (Gallus et al., 2021; Bhatta et al., 2022). One must therefore be especially careful when reporting "hearing loss" in the context of a viral disease.

That said, a substantial amount of COVID-19-related hearing loss literature deals with symptoms only, self-reported by a variable proportion of infected patients (up to 50%) (Elibol, 2021; AlJasser et al., 2022; Almishaal and Alrushaidan, 2022; Deva et al., 2022; Savtale et al., 2022; Vielsmeier et al., 2022). These reports often did not quantify or qualify the hearing (Wagatsuma et al., 2022), and therefore were limited in their contributions to the literature (Almufarrij and Munro, 2021; Trott et al., 2022). It is also important to consider that hearing loss may have been underreported by patients during the pandemic, as many patients avoided hospitals (by choice or not). Moreover, a large survey examining auditory symptoms from individuals with confirmed or suspected SARS-CoV-2 infection found inconsistent reporting and recall bias, as well as possible nocebo effects (Saunders et al., 2022). A scoping review concluded that the majority of patients who experienced hearing symptoms during COVID-19 did so within a month, most experiencing complete resolution within 2 weeks. The pattern was consistent with the natural history of a systemic viral infection (Ong and Cruz, 2022).

# 5. Conclusion

Since the onset of the pandemic, case reports regarding COVID-19 and hearing loss have been published, and pathophysiological mechanisms have been proposed. However, the quality of published literature is highly variable, reflecting the need for rapid dissemination of information during the worldwide pandemic. Although some reports of hearing loss attributed to SARS-CoV-2 are well documented, the literature does not support a significant rise in the occurrence of SSNHL or hearing loss in general. Therefore, in this ongoing COVID-19 era, hearing loss should be approached in the same state-of-the-art manner as before the pandemic, balancing the risks and benefits of therapeutic interventions.
