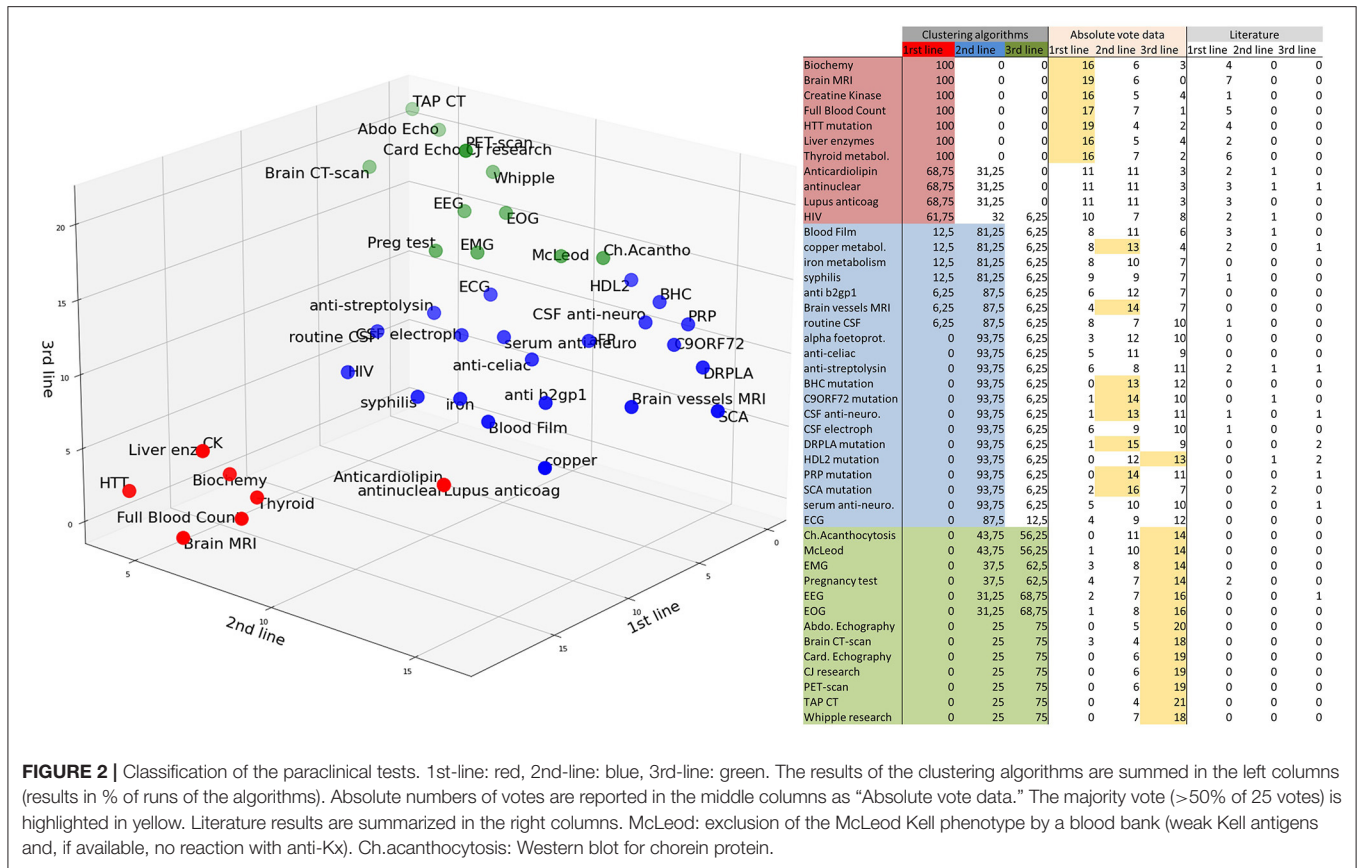

In the original article, there was a mistake in **Figure 2** and **Figure 3** as published. The figures were swapped incorrectly.

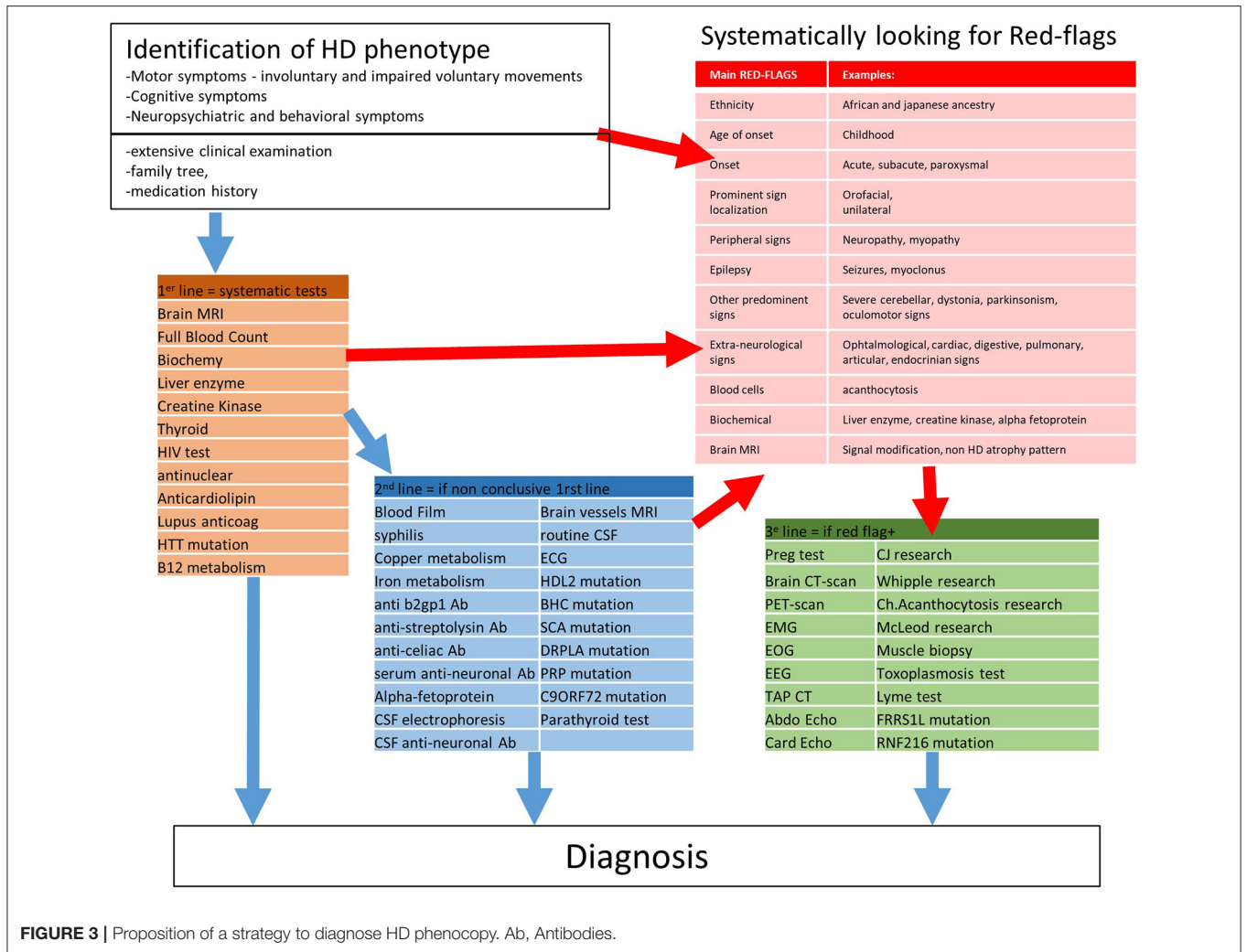
